



## Water is Essential. And So is Representation if It Causes You Harm.

**W**

ater is a living necessity. And when we turn on our taps for a drink or to bathe ourselves

or our children, we assume it's safe. However, corporations continue to take shortcuts often leading to mistakes to save money, giving little regard to the impact on local families – mothers, dads, children. Or they don't monitor and communicate the dangers. It happens everywhere; but it has also happened right here in the Mid-Ohio Valley – the place we call home. All because of one toxic chemical called C8.

C8 is the name given to perfluorooctanoic acid (PFOA), a man-made chemical used in manufacturing products that are a part of our daily lives. Some

applications include non-stick cookware, protective finishes on carpets, and water-resistant clothing.

DuPont's West Virginia Washington Works Plant in southwest Parkersburg released C8 into the air and Ohio River from the 1950s until the early 2000s. C8 reached drinking water supplies by seeping into the groundwater and was detected in six water districts near the DuPont plant in 2002.

A class action lawsuit brought by the communities against DuPont resulted in a Settlement Agreement in the Wood County Circuit Court. As part of that settlement, Brookmar Inc., an independent company, was set up and conducted a yearlong survey (August 2005 - July 2006) called the C8 Health Project. The C8 Health Project gathered

information through interviews and questionnaires and collected blood samples from about 69,000 people living near the Washington Works plant in West Virginia.

The settlement also established that a group of public health scientists would assess whether or not there is a probable link between C8 exposure and disease in the community.

It was found that exposure to PFCs like PFOA has been associated with cancer, high cholesterol, abnormal thyroid hormone levels, pregnancy-induced hypertension and preeclampsia, obesity and low birth weight.

Tens of thousands of local residents in the Mid-Ohio Valley were drinking untreated water contaminated at levels

# Product Liability Claims Involving Pharmaceutical Drugs.



**I**f you have been injured by a pharmaceutical drug you used, you may have a defective product claim. Pharmaceutical-drug-based product liability claims are similar to other defective product claims, but pharmaceutical-related injury claims have a number of special features.

## Types of Drug-Related Product Liability Claims

Drug-related product liability claims come in three basic varieties: claims based on defectively manufactured pharmaceutical drugs; pharmaceutical drugs with dangerous side effects (even though properly manufactured); and improperly marketed pharmaceutical drugs. (These parallel the three categories of defective product claims in general).

**Defectively Manufactured Pharmaceutical Drugs:** This category of claims involves injuries caused by pharmaceutical drugs that have been improperly manufactured or have somehow become tainted. This may be the result of an error at the manufacturing facility or the pharmacy where the drug was made or bottled, or a problem that occurs during shipping, or an error in labeling – in other words, any situation in which a mistake is made at any point between the factory and the place you receive the drug.

**Pharmaceutical Drugs with Dangerous Side Effects:** This category of claims

involves pharmaceutical drugs that, although properly manufactured, have side effects that result in injury. These cases sometimes involve drugs that have been on the market for a long time before it is discovered that they increase the risk of a certain type of injury, such as heart attacks. In some cases, the victims may claim that the manufacturer knew of the danger but deliberately concealed it. If the victims can prove this, they will get more money in the form of punitive damages.

**Improperly Marketed Pharmaceutical Drugs:** The "marketing" of a pharmaceutical drug refers to the warnings,


instructions, or recommendations concerning the use of that drug. This category often involves injuries caused by a failure to provide adequate or accurate warnings regarding a dangerous side effect or a failure to provide adequate instructions regarding the safe and appropriate use of the drug. The "bad advice" may have been given by the manufacturer or by a doctor, pharmacist, sales rep, or some other medical provider.

Keep in mind that your defective product lawsuit may include a combination of claims. For example, a claim based on a drug with a dangerous side effect may be coupled with a claim based on the failure to warn of that side effect. Each different type of claim may net a different subset of defendants. ## Grilled Chicken Tacos with Strawberry Salsa

Cinco De Mayo meets peak strawberry season with this delightfully fresh spring recipe from VA Leads and Intake Specialist, **Amanda Hartline**.



### INGREDIENTS:

1 1/2 lb. skinless, boneless chicken-breast halves  
1 tsp. chili powder  
1 tsp. canola oil  
12 fajita-size flour tortillas  
Olive oil cooking spray

8 oz. strawberries  
2 medium tomatoes  
1 medium avocado  
1 small shallot  
2 limes  
1/2 cup crumbled feta cheese  
2 cups Cilantro leaves

**DIRECTIONS:** Prepare outdoor grill for covered direct grilling on medium. Rub chicken with chili powder, oil, and 1/4 teaspoon of salt. Grill chicken, covered, 12 to 15 minutes or until cooked through (165°), turning over once halfway through. Transfer cooked chicken to cutting board. Let stand 5 minutes. Meanwhile, spray tortillas with cooking spray. Grill 1 to 2 minutes or until grill marks appear, turning over once halfway through. Transfer to plate. While chicken rests, in medium bowl, stir together strawberries, tomatoes, avocado, shallot, and 1/8 teaspoon salt. Squeeze juice of half of 1 lime into mixture, stirring to combine. Thinly slice chicken and serve in tortillas topped with strawberry salsa, feta, and cilantro. Garnish with remaining limes, cut into wedges.

that are dangerous and unacceptable. And you don't need to live near the West Virginia plant to be exposed to C8, which is one of the reasons the trials over this unregulated chemical have implications for all of us.

**DuPont and the seven other companies that made or used the chemical have all stopped doing so as of 2015. And the EPA now requires testing for the contaminant.**

Sadly, it is too late to fully remove C8 from all the bodies of water and human bloodstreams it now pollutes. As far as scientists can determine, C8 never breaks down and is expected to remain on the planet well after humans are gone from it.

There is some good news about C8: DuPont and the seven other companies that made or used the chemical have all stopped doing so as of 2015. And the EPA now requires testing for the contaminant. However, for those exposed and stricken with cancer, it's too late.
